### Send a Check

**Make it recurring!** Set up automatic payment to us on your financial institution's bill pay platform.

**Make it recurring!** Select "Monthly" under Donation Schedule on our website or "Monthly Donation" on GiveMN. Please note you will need a PayPal account to set up recurring donations on our website.

Many financial institutions offer one-time or [recurring](#) direct payments or [electronic funds transfers \(EFTs\)](#) from your bank to a nonprofit's account with no fees for either the donor or the organization. If interested, contact us and we can provide our account information.
